Scope of Services

Home Inspection

Capstone will conduct a comprehensive inspection that encompasses an analysis of the area's fire history, roads, and access points. Our home inspections will assess the fire risk and the property's ability to withstand fire conditions. We will examine the roof, structure, materials, surrounding hazards, and defensible space during the inspection. Any conditions identified that pose an immediate or future threat to life safety will be addressed by Capstone, where feasible, and communicated to the homeowner. A detailed report outlining our findings and recommendations will be provided, including necessary actions for the homeowner to reduce wildfire risk.

Capstone's teams will apply long-term retardant (LTR) to the non-irrigated areas surrounding your home before the fire season begins. This creates a protective barrier around the property, helping to slow the advance of fire and increasing our chances of preserving structures. The LTR used is completely safe for application on trees, shrubs, grasses, and other types of vegetation. It has undergone rigorous testing by the Federal Government and has been confirmed as safe for people, pets, and the environment. The water-based LTR continues to offer exceptional protection until it is washed away or after four inches of rainfall.

→ 24/7/365 Wildfire Monitoring - Elite Program

For our Elite Program members, Our monitoring team is available around the clock, every day of the year, to stay alert to any potential threats. They oversee various communication channels to detect fire hazards. If your home is at risk, we will notify you right away. Capstone will assess the situation and decide when to send resources to your residence.

Wildfire Response - Elite Program

For our Elite Program members, Capstone will take action at your home to initiate essential protective measures. Our team will evaluate immediate risks and begin triaging the property by eliminating any combustible hazards or leaf debris, sealing off vents, and applying fire gel along with other strategies when there is an imminent threat to the structure. Crews will keep a close watch on your home and may return for additional visits as necessary.

Equipment

Capstone's fire response teams deploy specialized fire apparatus designed for active fire incidents. In compliance with state regulations, our vehicles will be designated as "Non-Emergency Providers," meaning we will not respond with lights or sirens in a Code 3 manner. The equipment carried on our trucks meets and surpasses the federal standards for Wildland Fire Apparatus.
